SEVP Response Center and SEVIS Help Desk Merge

The Student and Exchange Visitor Program (SEVP) Response Center (SRC) and the SEVIS Help Desk recently merged to enhance customer service and to continue to improve the efficiency of SEVP daily operations.

Stakeholders calling the SRC and SEVIS Help Desk will notice a new interactive voice recording. The recording will ask for the nature of your call and then route you to the appropriate SEVP representative to address your questions.

As part of this consolidation, representatives from the U.S. Department of State will be available during the transition to answer questions related to J-1 exchange visitors. This consolidation better integrates partner agency operations to address stakeholder questions and concerns.

The phone numbers for the SRC and SEVIS Help Desk will remain the same. In lieu of the transition, the SRC and SEVIS Help Desk have permanently extended their hours. NEW! SEVIS by the Numbers Quarterly Report

According to recent international student data, there are 1,112,600 F & M students in the United States. Since October 2013, the number of F-1 and M-1 students has increased by 9 percent. Of those students, 75 percent are from Asia.

You can read about these insights and more in the latest SEVIS by the Numbers report. SEVIS by the Numbers is a quarterly report using data from SEVIS, which SEVP uses to track and monitor the status and activities of nonimmigrant students and exchange visitors studying in the United States. The report is a snapshot of useful information, including the number of international students in the United States, top places of origin and student demographics.

The latest report includes a special section focusing on India, which is the home country of the second largest group of F-1 and M-1 students in the United States.
