### **Going Somewhere?**

With the holiday season approaching, the Student and Exchange Visitor Program (SEVP) is publishing information for F and M students to keep in mind as they travel outside of the United States. To make their return easier, *Study in the States* is featuring a Travel Tuesday blog series throughout the month of December.

Topics focus on secondary inspection, the Form I-515A, "Notice to Student or Exchange Visitor," what to expect at the port of entry with a U.S. Customs and Border Protection officer, and general holiday travel tips. These posts promote preparing and hand-carrying important documents like the Form I-20, "Certificate of Eligibility for Nonimmigrant Status," a receipt of the I-901 Student and Exchange Visitor Information System (SEVIS) fee, and contact information for the student's designated school official. When students are prepared to re-enter the United States and know what to expect, the process is much easier.
