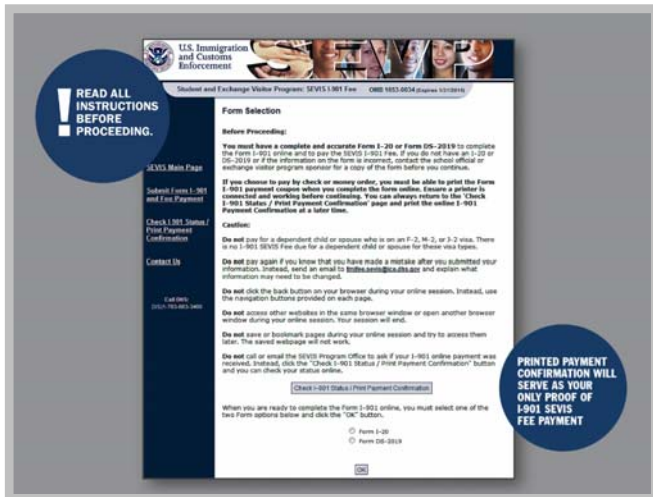

I-901 SEVIS Fee Payment Tutorial

As of Aug. 4, an F or M student no longer receives a mailed receipt after paying the I-901 Student and Exchange Visitor Information System (SEVIS) fee. Regulations require all prospective F and M students to pay the I-901 SEVIS fee before the U.S. Department of State will issue a visa. To explain this new process, the Student and Exchange Visitor Program (SEVP) developed an [I-901 SEVIS Fee Payment Tutorial](#).
