

Spring 2018 SEVP InFocus Webinar Glossary

Certification expiration date (CED): the date two years from the date of a school's previous Student and Exchange Visitor Program (SEVP) certification or recertification expiration date on which a school is required to file a completed petition for SEVP recertification.

Designated school official (DSO): a regularly-employed member of the school administration designated by the head of a Student and Exchange Visitor Program-certified school to provide recommendations to F and/or M students enrolled at the school regarding maintenance of nonimmigrant status, and to support timely and complete record keeping and reporting to the U.S. Department of Homeland Security.

Employment Authorization Document (EAD): a document issued by U.S. Citizenship and Immigration Services to nonimmigrants that provides proof of work authorization in the United States for a specific period.

Federal Bureau of Investigation (FBI): an intelligence-driven and threat-focused national security organization with both intelligence and law enforcement responsibilities to protect the U.S. from terrorism, espionage, cyber attacks and major criminal threats.

Federal Emergency Management Agency (FEMA): a U.S. Department of Homeland Security agency that helps the United States prepare for, prevent, respond to and recover from disasters.

Form I-17, "Petition for Approval of School for Attendance by Nonimmigrant Student:" the form for a petition submitted and maintained by school officials electronically in the Student and Exchange Visitor Information System for the Student and Exchange Visitor Program certification of the school to enroll F and/or M students.

Form I-20, "Certificate of Eligibility for Nonimmigrant Student Status:" the form issued to an F or M nonimmigrant to be used as authorization for admission in and maintenance of nonimmigrant status for the duration of their visit in the United States.

Form I-515A, "Notice to Student or Exchange Visitor:" a form issued by U.S. Customs and Border Protection at the port of entry to students who arrive without all of their required documents. The Form I-515A allows students to temporarily enter the United States. They have 30 days to submit the missing information to the Student and Exchange Visitor Program before their status is terminated.



Form I-983, "Training Plan for STEM OPT Students:" formal training plan that clearly articulates the science, technology, engineering and mathematics optional practical training student's learning objectives and affirms the employer's commitment to helping the student achieve those objectives.

Homeland Security Investigations (HSI): the investigative arm of the U.S. Department of Homeland Security that combats criminal organizations illegally exploiting U.S. travel, trade, financial and immigration systems.

Immigration and Customs Enforcement (ICE): a U.S. Department of Homeland Security agency that promotes homeland security and public safety through the criminal and civil enforcement of federal laws governing border control, customs, trade and immigration. Through the Student and Exchange Visitor Program, ICE helps secure the foreign student visa system.

Kindergarten to grade 12 (K-12): education levels students enroll in before advancing to higher education institutions. U.S. students usually begin a formal educational program around age five or six in kindergarten. Children then complete grade levels one through 12 before attending college or university. F and M students may enroll in a private program for any length of time but may only attend a public high school for one year.

National Security Investigations Division (NSID): A component of Homeland Security Investigations that leads the effort to combat criminal enterprises by investigating vulnerabilities in the nation's border, infrastructure, and economic and transportation systems.

Office of Academic Engagement (OAE): a U.S. Department of Homeland Security (DHS) office established to strengthen DHS' relationship with institutions of higher education in three functional areas of engagement, resilience and outreach.

Optional practical training (OPT): training that is not an integral part of the established curriculum. OPT does not fulfill requirements of an F-1 student's program of study and successful program completion is not contingent on participation in OPT. OPT may include:

- Pre-completion OPT
- Post-completion OPT
- 24-month extension of post-completion OPT
- H-1B cap gap

Principal designated school official (PDSO): a designated school official (DSO) with added responsibilities to:

 Serve as the primary point of contact with the Student and Exchange Visitor Program on any issues that relate to school bona fides or compliance with regulations.



- Administer the F/M program at the school, keeping the school information in the Student and Exchange Visitor Information System (SEVIS) up-to-date, manage DSOs, oversee the management of student records and respond to SEVIS-generated alerts.
- Submit school certification and recertification packages.

Project Campus Sentinel (PCS): an outreach program that partners with educational institutions to improve communications between designated school officials and Homeland Security Investigations special agents by providing training to identify criminal activity and a mechanism to report Student and Exchange Visitor Information System exploitation and fraud schemes that compromise national security.

Project Shield America (PSA): assists industry and academic research institutions to better understand current U.S. export laws and aids the recognition, detection and resolution of illegal acquisition attempts of controlled and sensitive commodities, technology and data by foreign governments, companies or individuals.

Science, technology, engineering and mathematics (STEM): science, technology, engineering and mathematics programs, which are important to innovation and job creation in the United States.

SEVP External Training Application (SETA): a learning management tool that provides training to Student and Exchange Visitor Program (SEVP) stakeholders, including U.S. government officials, school and program officials, and F, M and J nonimmigrants. The tool will provide training on a variety of subjects related to SEVP and the international student process.

SEVP Response Center (SRC): the primary contact at the Student and Exchange Visitor Program (SEVP) for nonimmigrant students, academic institutions, government users of the Student and Exchange Visitor Information System (SEVIS), and the general public requesting guidance, data corrections and information on how to use SEVIS.

Student and Exchange Visitor Information System (SEVIS): an internet-based application that facilitates timely electronic reporting and monitoring of international students and exchange visitors, as well as their dependents, in the United States. This application enables schools and program sponsors to transmit electronic information to the U.S. Department of Homeland Security and the U.S. Department of State throughout a student's or exchange visitor's program in the United States.

Student and Exchange Visitor Program (SEVP): a part of the National Security Investigations Division and acts as a bridge for government organizations that have an interest in information on nonimmigrants whose primary reason for coming to the United States is to be students. On



behalf of the U.S. Department of Homeland Security, SEVP manages schools, nonimmigrant students in the F and M visa classifications and their dependents.

- **U.S. Citizenship and Immigration Services (USCIS):** an agency within the U.S. Department of Homeland Security that authorizes benefits for students and exchange visitors. Students can request benefits such as employment, an extension of their stay or a change of status from USCIS.
- **U.S. Customs and Border Protection (CBP):** a U.S. Department of Homeland Security agency that secures the borders of the United States, including airports, land borders and seaports. When entering the country, F and M students go through inspections with CBP officers and must present proper documentation.
- **U.S. Department of Homeland Security (DHS):** a federal agency whose missions include preventing terrorism and enhancing security, managing U.S. borders, administering immigration laws, securing cyberspace and ensuring disaster resilience. Through Immigration and Customs Enforcement and the Student and Exchange Visitor Program, DHS secures the student visa system.
