Latest SEVIS by the Numbers Report Released

The April 2016 [SEVIS by the Numbers Report](#) includes several enhancements for improved presentation of information. The highlighted updates include a focus on M-1 students and the ability to report yearly trends.

In focusing on M-1 students, the report reveals that:

- Most M-1 students choose to study in Florida, California and Arizona.
- Sixty-four percent of M-1 students enroll in programs related to transportation or logistics, which can include studying aviation and railway industries.
- Chinese males make up the largest demographic of M-1 students, currently representing 23 percent of this population.

The report's year-to-year Student and Exchange Visitor Information System (SEVIS) data comparisons highlight several trends, including:

- A six percent increase in the number of active F and M students studying in the United States from March 2015 to March 2016.
- A 31 percent increase in the number of F and M students from India studying in the United States, from 148,360 students in March 2015 to 194,438 in March 2016.
